Dear Brothers,

Greetings from the Alumni Board. I am writing to inform you of the upcoming events, update our recent activities, and to vote for new Board members.

The annual open meeting of the Alumni Board of Trustees will be held Saturday, November 17th at 9:30 am in Lehigh in the University Center Room # 403. All members are invited and encouraged to attend.

We will also host cocktails with open bar at the Faculty Lounge of the University Center from 4pm to 8pm. Once again, University regulations allow for alcohol to be served for *only* one hour, which would be from 5:30 to 6:30 p.m. Reservations are not a necessity, but let me know (preferably via e-mail) so I have an accurate count.
